We kindly ask for your cooperation in abiding by the following ordinances to ensure a harmonious environment for all. Amplified Performances: Keep it Unplugged!

Residential Areas: You are around residential property, according to the City Regulations ensure that your sound is not audible in neighboring units. Let's keep the peace and avoid disturbing our neighbors.

Street Vendors

Vendor Nature: Street vending in the Old Market should be occasional and not in direct competition with permanent businesses that have their own owned or leased spaces.

Sidewalk Consideration: Given the narrow nature of Old Market sidewalks, please avoid obstructing pedestrian pathways at all times. Let's keep the walkways accessible for everyone's convenience and safety.

Required Permits and Documents: Make sure to display the following licenses and permits as listed in the **City Peddler Permit:**

- City of Omaha Municode – Peddler Permit
- Nebraska Sales Tax Permit
- Public Property Bond (\$10,000)
- Certificate of Liability Insurance (\$500,000)
- Permission from the property owner (including sidewalk area)
- Copy of Health Department Permit (if applicable)



Bikes, Rollerblades & Skateboards

As per the **City of Omaha Traffic Rules, Section 36-148:** (a) Riding, using, operating, racing, or propelling skateboards or bicycles on public sidewalks within the downtown business district and the Old Market **is prohibited** by law.



Scoters

- **Sidewalk Courtesy:** For everyone's safety, please refrain from riding your scooter on sidewalks. Utilize designated bike lanes and roadways.
- **No-Ride Zones:** Avoid entering designated No-Ride Zones, including the charming brick streets of the Old Market. Preserve the integrity of these areas for all to enjoy.
- **Age Requirement:** Scooter riders must be 18 years or older.
- **Operating Hours:** Enjoy your scooter adventures between 5am and 10:30pm. Let's respect our community's quiet hours.
- **Ordinance Compliance:** Per the City of Omaha Traffic Rules, Section 36-146: Operating a motorized scooter in violation of these regulations is subject to penalties.
