
Omaha Downtown Improvement District

The Omaha Downtown Improvement District Association (ODID) was established by public election (Ordinance 6874) in 2007. The ODID Board of Directors is comprised of volunteer elected representatives from the various constituencies within the District: businesses, residents, and property owners all have seats.

The mission of the association is to support, preserve, create, and enhance a clean, green safe, and active, competitive, and thriving Downtown Omaha that attracts and retains businesses, employees, residents, and visitors.

The Clean & Green Team maintains clean and beautiful public spaces; the Downtown Ambassadors provide friendly assistance to visitors and residents; a privately contracted security team operates in the evenings and on weekends; and a highly effective advocacy program focuses on everything from working with residents to assisting businesses in day to day needs. The association is also deeply involved in local events and activities produced for the public and sponsors several regular activation programs such as outdoor exercise classes, art walks, and outdoor music concerts.



Major City Plans

<u>Riverfront Revitalization Project</u> – A project with the City of Omaha and Heritage Services to improve the Riverfront and surrounding areas to fit the needs of the public. The programs with the most interest included bettering the connection with the river, waterfront trails, public restrooms, children's area, waterfront dining and much more. \$260 Million of private funding was raised to pay for this project. The City will contribute \$50 Million over 3 years.

Gene Leahy Mall: Ground broke – February 2019 with finish date projected in 3rd Quarter 2021

Heartland of American: Start 2nd Quarter of 2020 with finish date projected 3rd quarter 2023

Lewis & Clark Landing: Start 2nd Quarter of 2021 with finish date projected 1st Quarter 2023

<u>ORBT</u> – Omaha's first Bus Rapid Transit line, located on Dodge Street and connecting major destinations from Westroads Mall to the Old Market, is scheduled to begin service in 2020. 25 to 27 stations will offer more amenities than conventional bus stops; traffic signal technology will prioritize transit vehicles at major intersections plus designated travel lanes; and specialized vehicles departing every 10 minutes during rush hour will offer the highest level of transit service available in the region.

Continued Exploration for the Modern Streetcar – This 3.2-mile modern streetcar will serve as a "Downtown Connector" that will connect people and places between North Downtown, Downtown, Midtown and UNMC. Studies show this transit improvement could lead to more than one billion dollars in new development, thousands of jobs and significantly increase the residential population in Downtown Omaha. The Urban Circulator would accommodate 130-160 passengers per vehicle, it would share travel lanes and stops with buses, operate in mixed traffic and have room for bikes on board.


